## NOTICE OF APPROVAL

This Notice addresses Nerro Supply Investors, LLC's application for a pass-through rate increase due to an increase in pumpage, import, and surface water fees imposed on the utility by the San Jacinto River Authority under in its groundwater reduction plan. Hazy Hollow East Estates and White Oak Valley Estates are listed as the subdivisions affected by the pass-through rate increase. The proposed effective date for the rate increase is October 15, 2016.

On September 1, 2016, Commission Staff recommended that the application and notice be deemed sufficient and further that the application be approved; as specified in the pleading and attached memorandum of Patricia Garcia of the Commission's Water Utility Regulation Division. Commission Staff recommended approval of a pass-through rate of \$2.94 per 1,000 gallons, effective October 15, 2016 for Nerro's customers in the Hazy Hollow East Estates and White Oak Valley Estates. Commission Staff provided revised tariff pages for Nerro.

Consistent with Commission Staff's recommendation, Nerro's application is sufficient and it is approved. A new pass through rate of \$2.94 per 1,000 gallons for Nerro's customers in the Hazy Hollow East Estates and White Oak Valley Estates Subdivisions is approved for

### Pass Through Provision:

For Utilities subject to changes in costs imposed by any non-affiliated provider of purchased water or sewer or a groundwater conservation district having jurisdiction over the Utility, these increases (decreases) shall be passed through as an adjustment to the gallonage charge according to the formula:

ABR = BR + (BxN)/(1-L), Where:

ABR = adjusted base rate, rounded to nearest one cent;

B = approved gallonage charge, per 1,000 gallons;

N = no. of 1,000 gallons included in base rate (do not use zero);

L = water or sewer line loss for preceding 12 months, not to exceed 0.15 (15%)
