DEFINITIONS

- "Ranch Crest" or "you" refers to Utilities Investment Co., Inc. d/b/a Ranch Crest Water Company and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- **Staff 1-1** Please identify the number of current connections being served in Section 4 of the Ranch Crest Subdivision.
- Staff 1-2 Please identify the number of connections that will be served in Section 5 of the Ranch Crest Subdivision.
- **Staff 1-3** Provide one of the following:

- 1. The report from TCEQ addressing the 85% capacity rule pursuant to 30 Tex. Admin. Code § 291.93(3) (TAC) for Ranch Crest to provide water service to the additional 400 customers in the proposed amended area; or
- 2. The approved plans and specifications for the additional well to provide water service to the additional 400 customers in the proposed amended area
- **Staff 1-4** Please provide TCEQ's construction approval letter for the facilities necessary to serve the proposed area.
- Staff 1-5 Please provide documentation that the TCEQ violation issued on July 25th, 2013, for failure to provide a dual-feed chlorination system, has been resolved.
- Staff 1-6 Please provide proof that Utilities Investment Company Inc., d/b/a Ranch Crest Water Company (UICRC) has filed a 2015 PUC Annual Report for CCN No. 12932 and CCN No. 20874 pursuant to 16 TAC § 24.73.
- **Staff 1-7** Please provide the 2013 and 2014 financial statements for UICRC pursuant to 16 TAC § 24.11(e)(4)(B), including annual income statements, balance sheets, and statements of cash flows.
- **Staff 1-8** Please provide UICRC's business plans to serve the requested area in Attachment D1 and D2 as provided in the application. Please include the cost for UICRC to construct the new systems and infrastructure to serve the area. Additionally, pursuant to 16 TAC § 24.11(e)(5)(B), if Ranch Crest is proposing service to a new CCN area or a substantial addition to its current CCN area requiring capital improvements in excess of \$100,000, Ranch Crest must submit loan approval documents or firm capital commitments affirming funds are available to install plant and equipment necessary to serve projected customers in the first two years of projections, or a new water system or substantial addition to a currently operating water system if the application includes added CCN area with the intention of serving a new area or subdivision
