# ORDER NO. 2 DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's recommendation that the application of Rock Creek Water Supply Corporation and Possum Kingdom Water Supply Corporation for approval of a sale, transfer and merger involving certificate rights, facilities and existing customers in Palo Pinto County is sufficient for further review. This Order also addresses Commission Staff's notice recommendations and proposed procedural schedule.

### I. Administrative Completeness

On September 26, 2016, Commission Staff recommended the application be found sufficient and complete. Consistent with Commission Staff's recommendation, the application, including proposed notice, is deemed administratively complete.

#### II. Notice

Commission Staff also recommended that applicants be required to provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice. Consistent with Commission Staff's recommendation, applicants shall provide notice consistent with the instructions in Commission Staff's September 26, 2016 pleading and the attached memorandum of Ricky Herrera and Kristy Nguyen of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum. Applicants shall file an affidavit evidencing proof of notice by the deadline set forth below.

#### III. Procedural Schedule

Commission Staff proposed a procedural schedule for continued processing of this docket. Accordingly, the following procedural schedule shall apply:

Deadline for applicants to file affidavits of proof of notice	October 28, 2016	
Deadline for Commission Staff to file comments on proof of notice and propose additional procedural schedule, if appropriate	14 days after the deadline for the applicants to file poof of notice	
Deadline for intervention; deadline for intervenors to request a hearing on the merits	30 days after mailing of notice
