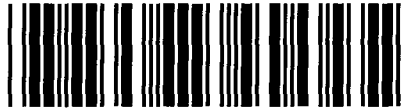

**ORDER NO. 1  
REQUIRING RESPONSES**

**I. Background**

On August 30, 2016, Silverleaf Resorts, Inc. (Silverleaf) filed a complaint against Liberty Utilities (Silverleaf) LLC f/k/a Algonquin Water Resorts of Texas, LLC (Liberty) alleging a violation of the obligation to timely file an Annual Report associated with the water and sewer system under Certificate of Convenience and Necessity Nos. 20815 and 13131, respectively. This complaint is filed under 16 Tex. Admin. Code § 22.242 (TAC) and is available on the Commission's Interchange.<sup>1</sup>

**II. Requiring Response**

Pursuant to 16 TAC § 22.78, Liberty shall file a response to the complaint no later than **September 14, 2016**, addressing the following:

1. the Commission's jurisdiction over this proceeding;
2. allegations raised in the complaint;
3. applicable statutes, rules, orders and/or tariff provisions;
4. copies of any rates/tariffs that are the subject of this complaint; and
5. any other matters relevant to the complaint.

**III. Statement of Position from Commission Staff**

Commission Staff shall file a statement of position by **September 21, 2016**.

**IV. Filings**

To ensure the efficient processing of this proceeding, all pleadings and other filings shall be deemed filed when the proper number of copies are presented to the PUC Filing Clerk for filing pursuant to 16 TAC § 22.71(c). All filings related to this docket can be accessed on the PUC Interchange.

**V. Ex Parte Communications**

Ex parte communications with the administrative law judge are prohibited. Parties should communicate with the administrative law judge only through written documents filed with the Commission's Filing Clerk and served on all parties.

The Office of Public Utility Counsel is notified of this proceeding by copy of this Order.
