DEFINITIONS

- A. "PK-RE" or "Company" refers to the PK-RE Development Company, Inc., d/b/a Greenshores Utility Services and d/b/a Oak Shores Water System and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. "Document" includes any written, recorded, or graphic matter, however produced or reproduced, including but not limited to correspondence, telegrams, contracts, agreements, notes in any form, memoranda, diaries, voice recording tapes, microfilms, pictures, computer media, work papers, calendars, minutes of meetings or other writings or graphic matter, including copies containing marginal notes or variations of any of the foregoing, now or previously in your possession. - Staff 2-1 Please provide all federal tax returns for PK-RE Development, Inc. and all affiliates who sold lots in the subdivisions served by the water and/or wastewater system from 2004 to the present. Include tax returns which reflect revenues and expenses for the development and the water and wastewater systems.
- Staff 2-2 Did PK-RE Development, Inc. or an affiliate expense any of the costs for the water and wastewater plant reflected in the application against sales of lots served by the water and/or wastewater plants on a tax return? Please provide a full list of assets expensed by NARUC chart of accounts number, name of plant item, and cost expensed.
- Please provide a reconciliation by individual plant item/component for water and sewer separately, if applicable, between rate cases filed by PK-RE Development, Inc. as follows: Texas Commission on Environmental Quality (TCEQ) application number 35402-G (Water), TCEQ application numbers 37438-R and 37439-R, and the plant totals and individual items claimed in this case.
- Staff 2-4 Please explain why the current application contains items installed in 2004 which were not reported on the plant schedule for TCEQ application number 35402-G (Water) as follows:
 - 1. Trench cut of \$46,694
 - 2. Main line engineering and legal of \$116,348
 - 3. 350,000 gallon GST Engineering & Legal-Greenshores of \$91,688
 - 4. New Water main of \$38,070
- Staff 2-5 Please provide paid invoices and work orders for all plant items listed on the water and wastewater depreciation schedules supporting the original cost of such assets by NARUC account number.
- Staff 2-6 Please provide an itemized list of all plant in service in this application that was expensed on any tax return for federal income tax purposes. The list should include the NARUC account in which the item is claimed in this application, the name of the item, the amount expensed on the tax return, the year installed, the year expensed, and the amount claimed on the application for the item.
- Staff 2-7 Provide all financial statements, (income statements, balance sheets) for PK-RE from 2004 to current.

- Staff 2-8 Provide general ledgers for PK-RE in Microsoft Excel format for the test year and one year prior to the test year.
- Staff 2-9 Provide the general journal including all adjusting journal entries used to develop the financial statements for PK-RE for the year and one year prior to the test year.
- Staff 2-10 Provide the amount of accumulated deferred federal income tax for the end of the test year and one year prior resulting from any accelerated depreciation taken for federal income tax purposes for the water and sewer assets and any other source. Provide all relevant calculations and source documents to support this number.
- Staff 2-11 Provide a list of all affiliated interests as defined by Texas Water Code §13.002(2).
- Staff 2-12 Are all the subdivisions prospectively to be served by PK-RE currently built out? If not, please provide the number of vacant lots by subdivision that will receive water and/or wastewater service from PK-RE in the future using the plant currently being claimed in this application.
