# PK-RE's RESPONSES TO COMMISSION STAFF'S SECOND RFI

STAFF 2-2 Did PK-RE Development, Inc. or an affiliate expense any of the costs for the water and wastewater plant reflected in the application against sales of lots served by the water and/or wastewater plants on a tax return? Please provide a full list of assets expensed by NARUC chart of accounts number, name of plant item, and cost expensed.

#### Response

For tax purposes, yes. PK-RE Development, Inc. affiliates PK-RE, Ltd. and Woods of Greenshores, Ltd. expensed the costs for the water and wastewater plant in the costs of lots sold for tax purposes. PK-RE Development, Inc. and its affiliates do not use NARUC accounting.

See Attachment Staff 2-2 for items expensed by these development companies as cost of lots sold before 6/30/07. Additionally, post 6/30/07, Woods of Greenshores, Ltd. had \$1,201,286.95 of costs as follows:

Ground Storage Tank-Keystone (38,500) Engineering-CBD \$115,458.44 Engineering-Burry Partners \$49,982.10 Utilities-Jobsite Construction \$1,057,346.41 Grinder Pumps \$17,000

These costs are not contributed capital because they are not on PK-RE Development, Inc.'s books and were not put in rate base. PK-RE Development, Inc. and its affiliates never received reimbursement for these contributions from customers.


