SECOND REVISED AGREED PROPOSED PROCEDURAL SCHEDULE

Undine Development LLC ("Undine") and files this Second Revised Agreed Proposed Procedural Schedule pursuant to SOAH Order No. 2 issued on April 10, 2017. The Administrative Law Judge asked for a revised schedule that allowed 60 days between reply briefs and the Proposal for Decision.

Concurrently with the filing of this proposed schedule, PK-RE Development Company, the Applicant in this docket, is filing an agreed extension of the effective date of its proposed rate increase in order to accommodate additional time in the procedural schedule in which to undertake settlement discussions of this docket and PUC Docket No. 46150. The extension of the effective date is the reason why all of the proposed deadlines have been extended in this filing.

Undine has conferred with PK-RE Development Company, Inc. d/b/a Greenshores Utility Services and d/b/a Oak Shores Water System, Cynthia Smiley, Alexander "Barry" Williams, John Carlton (counsel for Greenshores on Lake Austin Property Owners Association, Inc.), and Public Utility Commission ("Commission") Staff and is authorized to represent that these parties agree with this Second Revised Agreed Proposed Procedural Schedule. Undine has attempted to contact Mr. Francis Ainsa, representative of Woods of Greenshores Property Owners Association, Inc., by email and telephone to determine his position on the revised schedule, but has not heard back from him. The proposed schedule, updated from the last proposed schedule filed on April 4, 2017 is as follows:
