AGREED MOTION TO ABATE PROCEDURAL SCHEDULE

COMES NOW, Undine Development LLC ("Undine"), Intervenor herein, and files this Agreed Motion to Abate the Procedural Schedule, and in support hereof shows the following:

The parties to this proceeding have agreed to request an abatement of this schedule for a period of forty-five (45) days in order to finalize settlement negotiations to resolve this matter and PUC Docket No. 46150, *Application of PK-RE Development Company, Inc. d/b/a Oak Shores Water System and Undine Development LLC for Sale, Transfer, or Merger of Facilities and Certificate Rights in Travis County*. The parties intend for this abatement to apply to all on-going matters in both dockets, including objections and responses to discovery requests and the filing of testimony, effective as of Friday, June 16, 2017.

The parties ask that they be allowed to file a status report at the end of the 45-day period with an update on the settlement discussions and their proposal for bringing this matter to a resolution.

Counsel for Greenshores on Lake Austin Property Owners Association has conferred with Cynthia Smiley, Alexander "Barry" Williams, Frank Ainsa representative of Woods of Greenshores Property Owners Association, and Public Utility Commission Staff. In addition, counsel for Undine has conferred with PK-RE Development Company. All parties agree with this Agreed Motion to Abate the Procedural Schedule.

Therefore, the parties jointly request that the Administrative Law Judge enter an order consistent with the draft attached hereto as Exhibit A.




