SOAH ORDER NO. 7

GRANTING AGREED MOTION TO ABATE PROCEDURAL SCHEDULE, ADDRESSING REVISED EFFECTIVE DATE, INDEFINITELY CONTINUING HEARING, AND INDEFINITELY EXTENDING RECORD CLOSE DATE

On June 19, 2017, Undine Development LLC filed an Agreed Motion to Abate the Procedural Schedule (Motion) for 45 days to allow the parties an opportunity to finalize settlement negotiations. On June 20, 2017, in SOAH Order No. 6, the Administrative Law Judge (ALJ) granted the Motion in part, but not in full because the Motion did not provide for an extension of the jurisdictional deadline in this case. On June 22, 2017, Applicant PK-RE Development Company, Inc. filed a letter extending the effective date, which was April 9, 2017, an additional 45 days, to May 24, 2017. The letter states that the parties agree to the extension.

The letter addresses the ALJ's concerns described in SOAH Order No. 6. Accordingly, the Motion is **GRANTED** in full. The 45-day abatement applies to all ongoing matters in this proceeding. Based on the revised effective date, the previously-ordered 265-day suspension period results in a jurisdictional deadline of February 13, 2018. The hearing on the merits set for August 18, 2017, is **CONTINUED** indefinitely and the record close date is **EXTENDED** indefinitely. If the parties do not succeed in reaching a unanimous settlement of all issues in this case, the ALJ will set a new hearing date and state a new record close date when she sets the revised procedural schedule after input from the parties. As stated in SOAH Order No. 6, a status report shall be filed by August 1, 2017.
