STATUS REPORT

Undine Development LLC ("Undine") files this Status Report, pursuant to State Office of Administrative Hearings ("SOAH") Order No. 11, filed on September 20, 2017.

On September 15, 2017, Undine filed a Status Report in compliance with orders issued by the Administrative Law Judge, reporting on the settlement negotiations and requesting additional time to continue to work on a settlement due to delays caused by Hurricane Harvey. Order No. 11 granted the request and directed the parties to file a new status report by September 29, 2017.

The parties have reached agreement on all outstanding issues in this docket and in the docket concerning the application of Undine to purchase the assets of PK-RE Development Company, Inc. ("PK-RE"). The parties are finalizing all settlement documents.

In order to allow sufficient time for the parties to finalize the settlement agreement and associated documents in support of the settlement agreement, the parties ask that they be allowed to file the settlement documents in this docket and Docket No. 46150 by October 16, 2017.

All parties agree with this Status Report.
