STATUS REPORT

NOW COMES, Undine Development LLC (“Undine”) and files this Status Report.

On September 29, 2017, Undine filed a Status Report in compliance with orders issued by the Administrative Law Judge, reporting on the settlement negotiations and stating that parties had reached agreement on all outstanding issues in this docket and in PUC Docket No. 46150 (“STM Docket”), the application of Undine to purchase the assets of PK-RE Development Company, Inc. (“PK-RE”).¹ Order No. 12 granted the request and directed the parties to file the settlement documents by October 16, 2017. On October 16, Undine filed an Agreed Motion to Request Extension of Time for Filing Settlement Documents, asking for a 7-day extension from the deadline established in SOAH Order No. 12, filed on October 6, 2017. This Status Report is being filed pursuant to that extension request.

Although the parties reached a settlement, not all of the parties have provided their signatures necessary in order for a unanimous settlement agreement to be filed. Undine anticipates that the final signature will be provided soon. Therefore, Undine requests that the Administrative Law Judge allow the parties an additional seven (7) days in which to obtain the remaining signature and file the settlement documents in this matter.


