PK-RE'S RESPONSE TO ORDER NO. 18

NOW COMES, PK-RE Development Company, Inc., d/b/a Greenshores Utility Services, d/b/a Oak Shores Water System (PK-RE) and files this Response to SOAH Order No. 18,¹ and in support thereof respectfully shows as follows:

On November 12, 2018, PK-RE filed a motion to withdraw its rate application that is the subject of this docket pursuant to the terms of a Settlement Agreement reached in PUC Docket No. 46150.² SOAH Order No. 18 directed PK-RE to file by November 20, 2018, a statement clarifying whether it requests the dismissal of this case with or without prejudice. This response is timely filed.

PK-RE respectfully requests that the case be dismissed with prejudice.

Therefore, PK-RE requests that the Public Utility Commission of Texas grant its motion to withdraw with prejudice, and grant all other relief to which it is justly entitled.
