COMES NOW, Undine Development LLC ("Undine") and files this Motion to Intervene in the above-styled and docketed proceeding pursuant to 16 Tex. Admin. Code §§ 22.101 and 22.104. In support of its Motion, Undine shows as follows:

- 1. On October 12, 2016, PK-RE Development Company, Inc. d/b/a Greenshores Utility Services and d/b/a Oak Shores Water System ("PK-RE") filed an application to change rates and tariffs in Travis County.
- 2. Undine has a justiciable interest in this proceeding, as PK-RE has also filed an Application for Sale, Transfer, or Merger ("STM") of a Retail Public Utility, stating its intent to sell all of the Water Systems under CCN No. 12407 and all of the Sewer Systems under CCN No. 20948, to Undine.
 - 3. The STM application is pending in PUC Docket No. 46150.
- 4. Undine and PK-RE intend to jointly prosecute this rate application in order to have the rates in place prior to the closing of the above-mentioned STM application.
