SOAH ORDER NO. 2 MEMORIALIZING PREHEARING CONFERENCE; ADOPTING PROCEDURAL SCHEDULE; AND NOTICE OF HEARING

The parties appeared for a telephone prehearing conference before the undersigned Administrative Law Judge (ALJ) on March 13, 2017.

During the conference, the City of Tomball (Applicant) challenged party status of Quadvest, L.P., and Undine Texas, LLC, (Intervenors). Intervenors argued that they were properly admitted as parties, and both Intervenors and Staff of the Public Utility Commission of Texas argued that the time for challenging the motions to intervene, which were filed on January 6, 2017, had passed. The ALJ agreed that, under 22 Texas Administrative Code § 22.78, the deadline for responded to the motion had passed and denied Applicant's request to reconsider party standing.
