



DEFINITIONS

- A. "Tomball" or "you" refers to the City of Tomball and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- B. - Staff 1-3** Please submit Tomball's bond rating from any of the following applicable agencies; Standard & Poor's Financial Services LLC, Moody's Investors Service, or Fitch Ratings Inc.
