COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files its Recommendation on Administrative Completeness. In support of its Recommendation on Administrative Completeness, Staff states the following:

I. Background

The City of Tomball requests water and sewer certificates of convenience and necessity for a service area located in Harris and Montgomery Counties. The City of Tomball states that it currently has a water and a sewer system to serve existing residents in the proposed service area.

On September 6, 2016, the Administrative Law Judge issued Order No. 1, which requires Staff to file its recommendation on the administrative completeness of the City of Tomball's application.

II. Applicable Statutes and Rules

A. Granting a Certificate of Convenience and Necessity

The Texas Water Code details the requirements for granting a certificate of convenience and necessity (CCN). In determining whether to grant a CCN, the Commission "shall ensure that the applicant possesses the financial, managerial, and technical capability to provide continuous and adequate service." The Commission's substantive rules have similar requirements.²

B. Administrative Completeness

In order for a CCN application to be processed, the Commission's substantive rules require that the Commission make a determination of administrative completeness. A CCN application is not considered filed "until the commission makes a determination," of administrative completeness." "If the commission determines that material deficiencies exist in any pleadings, statement of intent, applications, or other requests for commission action addressed by this chapter, the notice or application may be rejected and the effective date suspended until the deficiencies are corrected."

III. Staff's Recommendation

Staff has reviewed the City of Tomball's application and accompanying mapping data, and Staff recommends that the Commission deem the application not administratively complete. Staff has identified the following deficiencies in the City of Tomball's application:

- a. The City of Tomball needs to provide a small scale (general location) map showing only the proposed service area(s) with enough detail to be accurately located in the vicinity of the nearest town, city, or county. City limit data should not be included.
- b. The City of Tomball needs to provide a large scale (detailed) map showing <u>only</u> the proposed service area(s) with enough detail to be accurately located in reference to verifiable manmade and/or natural landmarks such as roads, railroads, and rivers. City limit data should not be included.
- c. The City of Tomball needs to provide digital data including only the proposed service area(s) as a single polygon record, in either a drawing (DWG) or shapefile (SHP) format on a data disk (CD) or submit metes and bounds (legal description). The details of the coordinate system or projection used to create the digital data must be included. The total acreage for the proposed digital data must match the acreage listed on the notice. If the acreage is revised, the

Staff's recommendation is based on the attached memorandum from Greg Charles of the Water Utilities Division.

notice documents must also be revised.

Staff recommends the City of Tomball be given until October 31, 2016 to amend its application in order to cure the deficiencies identified by Staff. Staff will then review this amended application for administrative completeness by November 14, 2016. In the event that Staff recommends that the Commission find that the City of Tomball's amended application is administratively complete, Staff will propose a procedural schedule.

IV. Conclusion

Staff recommends that the Commission find that the City of Tomball's application is not administratively complete due to certain deficiencies identified by Staff. Staff recommends that the City of Tomball be given an opportunity to cure the deficiencies identified by Staff.

Certificates of Convenience and Necessity in Harris and Montgomery Counties.

On September 1, 2016, the City of Tomball filed with the Public Utility Commission of Texas an application to obtain new water and sewer Certificates of Convenience and Necessity (CCN) in Harris and Montgomery Counties. The application is being reviewed pursuant to TWC §§ 13.242-13.250 and 16 Tex. Admin. Code (TAC) §§ 24.101-24.107.

Based on a review of the information in the application, Staff recommends that the application be deemed insufficient for filing and found administratively incomplete.

The digital data and hard copy maps do not display the same proposed service area. Furthermore, the proposed area overlaps with the following entities:

- Pinehurst Decker Prairie WSC (CCN No. 11768)
- Aqua Texas Inc (CCN No. 13203 and 21065)
- HOE WSC (CCN No. 12756)
- Albury Manor Utility Company (CCN No. 11507)

- Nerro Supply Investors LLC (CCN No. 10336)
- Quadvest LP (CCN No. 20952)

Districts:

- HMW SUD

To resolve the mapping deficiencies the following items are needed:

- 1) A small scale (general location) map showing only the proposed CCN service area(s) with enough detail to be accurately located in the vicinity of the nearest town, city, or county. Please do not include city limit data; and
- 2) A large scale (detailed) map showing only the proposed CCN service area(s) with enough detail to be accurately located in reference to verifiable man-made and/or natural landmarks such as roads, railroads, and rivers. Please do not include city limit data; and
- 3) Digital data including <u>only</u> the proposed CCN service area(s) as a single polygon record, in either a drawing (DWG) or shapefile (SHP) format on a data disk (CD) **OR** submit metes and bounds (legal description). Include the details of the coordinate system or projection used to create the digital data; and
- 4) Ensure that Items 1-3 include the same proposed area.

It is suggested the Applicant use PUC's official CCN digital data to obtain the current water and sewer CCN data to remove the overlaps. Overlaps with district boundaries require the Applicant to provide a letter of consent from each overlapping District listed above, allowing the Applicant to provide retail water and sewer service within the district's boundaries. The Applicant should contact Kristy Nguyen to obtain guidance to resolve the mapping deficiency issues.
