COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files its Supplemental Recommendation. In support of its Supplemental Recommendation, Staff states the following:

I. Background

The City of Tomball requests water and sewer certificates of convenience and necessity for a service area located in Harris and Montgomery Counties. The City of Tomball states that it currently has a water and a sewer system to serve existing residents in the proposed service area.

On October 5, 2016, the Administrative Law Judge issued Order No. 2, which deemed the City of Tomball's application not administratively complete. Order No. 2 also gave the City of Tomball the opportunity to cure the deficiencies in its application.

II. Applicable Statutes and Rules

A. Granting a Certificate of Convenience and Necessity

The Texas Water Code details the requirements for granting a certificate of convenience and necessity (CCN). In determining whether to grant a CCN, the Commission "shall ensure that the applicant possesses the financial, managerial, and technical capability to provide continuous and adequate service." The Commission's substantive rules have similar requirements.²

B. Administrative Completeness

In order for a CCN application to be processed, the Commission's substantive rules require

that the Commission make a determination of administrative completeness.³ A CCN application is not considered filed "until the commission makes a determination of administrative completeness." "If the commission determines that material deficiencies exist in any pleadings, statement of intent, applications, or other requests for commission action addressed by this chapter, the notice or application may be rejected and the effective date suspended until the deficiencies are corrected."⁵

III. Staff's Supplemental Recommendation

Staff has reviewed the additional mapping information submitted by the City of Tomball, and Staff recommends that the Commission deem City of Tomball's application to be administratively complete.⁶ With regard to notice, Staff recommends that the City of Tomball provide notice to the following:⁷

- a. Any districts, utilities and cities within two (2) miles of the proposed service area;
- b. Any city with an extraterritorial jurisdiction that overlaps the proposed service area;
- c. The county judge of each county in the proposed service area; and
- d. Any groundwater conservation district that is wholly or partly included in the proposed service area.

The City of Tomball should include with the notice of its application a copy of a map that shows the proposed service area(s) with enough detail to accurately locate the proposed service area(s) in reference to verifiable man-made and/or natural landmarks such as roads, railroads, and rivers.

In addition to the entities listed above, attached to this Supplemental Recommendation is a list of specific entities that must receive notice of the City of Tomball's application.

Staff also recommends that the City of Tomball publish notice of its application once each week for two consecutive weeks in newspapers of general circulation in Harris and Montgomery

Counties, Texas.

V. Procedural Schedule

To assist in the processing of the City of Tomball's application, Staff requests that the Commission adopt the following procedural schedule:

Event	Deadline
Deadline for the City of Tomball to file affidavits regarding the provision and publication of notice	December 19, 2016
Deadline for Staff to file a supplemental procedural schedule	December 28, 2016
Intervention deadline and deadline for intervenors to file comments or request a hearing	30 days after the mailing or publication of notice, whichever occurs later

IV. Conclusion

Staff recommends that the Commission deem the City of Tomball's application administratively complete and adopt the proposed procedural schedule detailed above.

On September 1, 2016, the City of Tomball (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to obtain a water and sewer CCN in Montgomery and Harris Counties, Texas pursuant to Texas Water Code Ann. (TWC), §§ 13.242 to 13.250 and the 16 Tex. Admin Code (TAC) §§ 24.101 to 24.107:

A Staff review of supplemental filings on November 4, 2016, found that the information is sufficient for filing and recommends the application be deemed administratively complete. Staff further recommends the following:

- 1) The Applicant be ordered to provide notice of the application to the following:
 - a) any districts, utilities, and cities within five (5) miles of the proposed area;
 - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
 - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified;
 - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN is located; and
 - e) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Montgomery and Harris Counties Counties.
