



COMMISSION STAFF'S RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Recommendation and would show the following:

I. BACKGROUND

On April 6, 2018, Douglas Utility Company (Douglas) filed Compliance Report No. 1 in accordance with the Final Order in Docket No. 42860.¹ That Order required Staff to make its recommendation on the compliance report within fourteen days after being filed. On March 26, 2019, Order No. 1 indicated that Staff had not made yet its recommendation and gave a deadline of April 9, 2019 for Staff to remedy that omission. This pleading, therefore, is timely filed.

II. RECOMMENDATION

Staff has reviewed Douglas' first filing and recommends that it be found in compliance with the Final Order in Docket No. 42860. In that Order, Ordering Paragraph No. 5 required Douglas to "include any information necessary to show Douglas completely refunded the overcollected charges, including the applicable interest." Stipulation No. 17 in that Order indicated that those charges, including applicable interest, totaled \$389,689.22. In its first compliance filing, Douglas asserts that it has completely refunded that amount by the ordered deadline. To support this assertion, Douglas included a repayment schedule history and copies of the corresponding checks for each refund, totaling \$389,689.22, with its filing.
