Pursuant to Order No. 3, mediation in this matter was withdrawn and the parties were ordered by this Court to file a proposed procedural schedule that includes three agreed dates for a hearing. The Office of Public Interest Counsel (OPIC) submits the following proposed schedule:


February 3, 2014	Discovery period commences; Responses due within 30 days.
April 1, 2014	Discovery request deadline
June 6, 2014	Town of Woodloch prefiled evidence due
July 3, 2014	Protestant prefiled evidence due
August 1, 2014	ED's and OPIC's prefiled evidence due
August 12, 2014	Objections to prefiled evidence due
August 22, 2014	Responses to objections to prefiled evidence due
September 16, 2014	Prehearing conference
September 22, 2014 to September 24 2014; September 24, 2014 to September 26, 2014; or September 29, 2014 to October 1, 2014	Evidentiary hearing

OPIC has included three suggested dates for the evidentiary hearing as ordered, noting that the Public Utilities Commission will assume jurisdiction on September 1, 2014. The parties, including the Executive Director, respectfully request that nothing be scheduled within two weeks of that date.
