



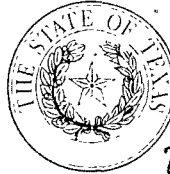

EXECUTIVE DIRECTOR'S STATUS REPORT




