The referenced petition was received by the Texas Commission on Environmental Quality (TCEQ) on April 19, 2013, and subsequent information received on April 22, 2013. The petition has been accepted for filing and assigned Docket No. 2013-0926-UCR. Please reference all further communications regarding this petition with this number.

This matter has been referred to the State Office of Administrative Hearings to schedule a hearing. A date for a preliminary hearing on this matter will be scheduled and you will receive notice of the time and place for this hearing. I have requested that the utility provide notice of the preliminary hearing to all affected ratepayers.

At this preliminary hearing, the TCEQ will first establish jurisdiction. The jurisdictional issues may include the filing date of the petition, percentage of customers signing the petition and the validity of the signatures on the petition. If jurisdiction is established, an attempt to reach an agreed settlement on this case may be made. If a settlement is not possible, then a schedule for discovery, prefiled testimony and another hearing date will be set.
