### COMMISSION STAFF'S FINAL RECOMMENDATION AND REQUEST FOR AN EXTENSION

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Final Recommendation and Request for an Extension and would show the following:

#### I. BACKGROUND

On September 29, 2016, the City of Donna (Donna) filed an application to amend its water certificate of convenience and necessity (CCN) No. 12790 in Hidalgo County and decertify a portion of North Alamo Water Supply Corporation's CCN No. 10553.

On April 20, 2017, Order No. 3 was issued, deeming the application administratively complete and establishing a deadline of June 2, 2017 for the parties to file a joint proposed notice of approval.

### II. 'RECOMMENDATION

As detailed in the attached memorandum from Patricia Garcia in the Commission's Water Utility Regulation Division, Staff has reviewed the application and recommends that it be approved. A CCN map and certificates reflecting the changes requested in the application are attached.

### III. PROCEDURAL SCHEDULE

Order No. 3 established Staff's recommended procedural schedule, which included a deadline of June 2, 2017 for the parties to file a joint proposed notice of approval, but did not include a deadline for the filing of a final recommendation from Staff. Because Staff typically

proposes procedural schedules that include time between the filing of a final recommendation and the filing of a joint proposed notice of approval, and because the parties are still in the process of drafting a joint proposed notice of approval, Staff requests that the deadline for filing a joint proposed notice of approval be extended to June 16, 2017

#### IV. CONCLUSION

Consistent with the discussion above, Staff recommends that the application be approved and that the deadline for filing a joint proposed notice of approval be extended until June 16, 2017.

On September 29, 2016, the City of Donna (City or Applicant) filed an application to amend the City's water Certificate of Convenience and Necessity (CCN) No. 12790 and to decertify a portion of North Alamo Water Supply Corporation's (North Alamo WSC) water CCN No. 10553 in Hidalgo County. The application is being reviewed pursuant to Texas Water Code § 13.255 (TWC) and 16 Tex. Admin. Code (TAC) §§§ 24.103(c), 24.105(d) and 24.120.

The application was accepted for filing on April 20, 2017. The application included minutes from the North Alamo WSC board meeting held on August 10, 2006, discussing and approving the release of the tract of land to the City, a letter from North Alamo WSC to the City, dated January 17, 2007, confirming the approval of the release of land, and a copy of the City's compensation to North Alamo WSC for release of the CCN service area, dated January 17, 2007. The result of this agreement is that the City's CCN No. 12790 will be amended to include approximately 23 acres from North Alamo WSC's water CCN No. 10553. The City has demonstrated compliance with the Commission's minimum requirements for public drinking water systems pursuant to TWC §13.255(m).

Consent to the proposed final map was filed by the City on May 30, 2017 and North Alamo WSC on May 31, 2017.

The City and WSC have met the requirements to allow for the transfer of requested area; therefore, Staff recommends that the Commission approve the application. Staff further recommends that the City and the WSC file a copy of the CCN map along with a written description of the CCN service area in the appropriate county clerk's office pursuant to Texas Water Code § 13.257(r) and (s).


