JOINT MOTION TO ABATE PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and MSEC Enterprises, Inc. (MSEC) who file this Joint Motion to Abate the Procedural Schedule. In support thereof, Staff would show the following:

i. Background

On September 29, 2016, MSEC Enterprises, Inc. (MSEC) filed an application to amend its sewer certificate of convenience and necessity (CCN) no. 20984 in Montgomery County. The total area requested includes approximately 38 acres of land and no current customers.

On December 28, 2016, Order No. 3 was issued deeming the application administratively complete and requiring Staff to file a final recommendation by February 21, 2017. In order to complete its technical review of the application and file its final recommendation by the February 21, 2017 deadline, Staff's 2nd RFI to MSEC was also filed on December 21, 2016. Responses were due on January 10, 2017. MSEC is in the process of providing Staff with responses to its RFIs, and discussions are ongoing. The Parties request abatement of this proceeding until March 17, 2017 to resolve the issues related to the RFIs. On that date, the Parties will file a status report requesting a new procedural schedule for the continued processing of this docket or continued abatement.

II. Conclusión
