COMMISSION STAFF'S MOTION TO UNABATE AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Commission), representing the public interest and files this Motion to Unabate and Proposed Procedural Schedule and would show the following:

I. BACKGROUND

On October 3, 2016, MSEC Enterprises, Inc. filed with the Commission an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12887 in Montgomery County. Order No. 5, issued on May 22, 2017, granted Staff's and MSEC's Motion to Abate and set June 19, 2017 as the deadline for parties to file a joint status report or joint motion to unabate.

II. MOTION TO UNABATE

MSEC provided additional information that is needed for Staff to complete its evaluation of the application. Staff requests that the proceeding be unabated so that Staff may complete its review of the application. Staff proposes the following procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to MSEC for review and consent	July 28, 2017
Deadline for MSEC to file signed consent forms with the Commission	August 11, 2017
If no hearing is requested, deadline for Staff to file a final recommendation on the application	August 18, 2017

If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law

August 25, 2017

Staff is authorized to represent that MSEC supports this request.
