JOINT REQUEST FOR EXTENSION OF TIME AND REVISIONS TO PROCEDURAL SCHEDULE

MSEC Enterprises, Inc. ("MSEC") and Public Utility Commission ("Commission") Staff file this Joint Request for Extension of Time and Revisions to Procedural Schedule.

Order No. 6 (June 15, 2017) established a deadline of July 28, 2017, for Commission Staff to provide final maps, certificates, and tariffs to MSEC for its review and consent. The Order also established a deadline of August 11, 2017, for MSEC to file its signed consent forms with the Commission. Due to personnel changes at the Commission, MSEC did not receive the proposed map, certificate, and tariff until August 3, 2017. Since that time, MSEC has reviewed the materials and has identified a need to modify information contained in the tariff. However, because of vacation and conference schedules, Commission Staff and MSEC have been unable to confer on the modifications.

MSEC and Commission Staff have deliberated, and agree that additional time is needed to confer on the tariff issues and to allow MSEC to determine whether it can consent to the documents provided by Staff. Therefore, MSEC and Commission Staff respectfully request that the procedural schedule established in Order No. 6 be revised to provide an additional seven (7) days for each of the remaining deadlines (i.e., MSEC's deadline would change to August 18, Staff's final recommendation would change to August 25, and the deadline for parties to jointly file proposed findings and conclusions would change to September 1, 2017).
