MANAGEMENT & TRAINING CORPORATION'S UPDATE ON SETTLEMENT DISCUSSIONS

COMES NOW, Management & Training Corporation ("MTC") and files this Update on Settlement Discussions ("Update") in accordance with the Public Utility Commission of Texas' Administrative Law Judge's Order No. 3, and in support of the same would show as follows:

On January 5, 2017, MTC filed with the Public Utility Commission of Texas ("Commission") an update on the settlement discussions between MTC and the City of Overton (the "City") regarding the Billy Moore Correctional Center's water and wastewater rates. By way of background, MTC contracts with the Texas Department of Criminal Justice to operate the Billy Moore Correctional Center (the "Prison").

At this time, negotiations between the City and MTC have concluded, and the parties have reached an agreement in principle that resolves the issues discussed in MTC's petition and establishes the rates and method by which the City may assess the water and wastewater rates for the Prison. The settlement agreement has been documented in writing, however, the Overton City Council does not convene until March 17, 2017. Thus, full execution of the settlement agreement will not occur until March 17, 2017. Therefore, MTC anticipates filing a Motion to Dismiss its petition to the Commission appealing the City's water and wastewater rates for the Prison by April 10, 2017, if the Overton City Council formally approves the settlement agreement as it currently

exists. The parties both agree that this written settlement agreement also resolves the Commission's pending case regarding this matter.

Therefore, MTC requests that the Commission Administrative Law Judge find good cause to provide MTC until April 10, 2017, to file a Motion to Dismiss or an alternative motion depending upon the Overton City Council's approval.
