**J&S WATER COMPANY, LLC'S  
REQUEST FOR AN EXTENSION OF TIME**

COMES NOW, J&S Water Company, LLC and files this Request for an Extension of Time and in support of the same would show as follows:

**I. BACKGROUND**

On October 13, 2016, J&S Water Company, LLC ("J&S Water") filed with the Public Utility Commission of Texas ("Commission") an application for a Class B rate/tariff change for water and sewer service under Certificate of Convenience and Necessity ("CCN") Nos. 12085 and 20658 (the "Application").

Commission Order No. 3 (issued by a Commission Administrative Law Judge ("ALJ") on January 23, 2017) found the Application sufficient and suspended the rate change effective date of April 1, 2017 for 265 days. Staff has requested a hearing in this matter.

On January 26, 2017, as recommended by Staff in its Order of Referral, the Commission referred this case to the State Office of Administrative Hearings ("SOAH"). In this same order, J&S Water and the Commission Staff were ordered to submit a list of issues to be addressed by February 13, 2017, so that the Commission could establish the issues on March 9, 2017.


**II. REQUEST FOR AN EXTENSION OF TIME**
