COMMISSION STAFF'S CORRECTION TO NOTICE OF APPROVAL

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Correction to Notice of Approval, and would show the following:

I. BACKGROUND

On October 18, 2016, the City of Royse City (Royse City) filed an application to amend its water and sewer certificate of convenience and necessity (CCN) Nos. 12827 and 20813 and to cancel Verandah Municipal Utility District's water and sewer CCN Nos. 13101 and 20958 in Hunt and Rockwall Counties. On May 18, 2017, the Notice of Approval was issued in this proceeding.

II. CORRECTION TO NOTICE OF APPROVAL

Pursuant to 16 Tex. Admin. Code § 22.35(c)(1), "[p]arties may file suggested corrections to a notice of approval within 15 days of the issuance of such notice." Staff was informed that the water certificate submitted by Staff and included with the Notice of Approval contains the incorrect water CCN number, and that the sewer certificate contains typographical errors. Staff is attaching the corrected certificates and requests that the Administrative Law Judge issue a corrected Notice of Approval.
