### **COMMISSION STAFF'S RECOMMENDATION REGARDING ADMINISTRATIVE COMPLETENESS AND REQUEST TO RESTYLE THE DOCKET**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 1, Recommendation Regarding Administrative Completeness, and Request to Restyle the Docket.

#### I. Background

On October 18, 2016, the City of Royse City (City) filed an application to amend its water and sewer certificates of convenience (CCN) Nos. 12827 and 20813 and to decertify a portion of Verandah Municipal Utility District's (Verandah MUD) water and sewer CCNs in Hunt and Rockwall Counties pursuant to Tex. Water Code §§ 13.242-.250 (TWC) and 16 Tex. Admin. Code §§ 24.101-.107 (TAC).

On October 24, 2016, the Administrative Law Judge (ALJ) issued Order No. 1 requesting Staff to file comments on the administrative completeness of the application and proposed notice and propose a procedural schedule by November 18, 2016. Therefore, this Recommendation is timely filed.

#### II. Staff's Recommendation on Administrative Completeness

Staff reviewed the application pursuant to TWC §§ 13.242-.250 and 16 TAC §§ 24.101-.107. As explained in the attached memorandum (Attachment A) of Ricky Herrera and Gary Horton Jr. of the Water Utilities Division, Staff recommends the application be deemed administratively complete.

#### III. Staff's Recommendation on Notice ~

Staff reviewed the City's proposed notice and recommends the City be directed to provide notice using the attached notice form (Attachment B). In accordance with 16 TAC § 24,106, Staff recommends the City be ordered to provide notice to any districts, utilities, and cities within two miles of the proposed service area, the county judge of each county and each groundwater conservation district wholly or partially included in the proposed service area, any city with an extraterritorial jurisdiction which overlaps the proposed service area, and any landowners who own a tract of land with at least 25 acres wholly or partially included in the proposed service area. In addition to those systems identified in the application, Staff recommends the City provide notice to the entities listed in Attachment A. Staff further recommends the City be directed to include a copy of a map showing the proposed service areas with the individual notices provided to neighboring utilities, customers, and other affected parties.

Staff also recommends the City publish notice once each week for two consecutive weeks in a newspaper of general circulation in Hunt and Rockwall Counties using the attached published notice form (Attachment C). Staff recommends the City be ordered to file copies of the actual notices and map sent along with the signed affidavits (Attachment D) with the Commission after providing notice in accordance with 16 TAC § 24.106.

#### IV. Staff's Request to Restyle the Docket

As currently styled, this docket indicates the City is requesting not only to amend its water and sewer CCNs, but also to decertify a portion of Verandah MUD's water and sewer CCNs. After reviewing the application, Staff recommends the docket be restyled to reflect that the City is seeking to cancel Verandah MUD's water and sewer CCNs rather than decertifying a portion of Verandah MUD's service area. Staff respectfully requests the docket be restyled to: "Application of the City of Royse City to Amend its Water and Sewer Certificates of Convenience and Necessity (CCN) and Cancel Verandah Municipal Utility District's CCNs in Hunt and Rockwall Counties."

#### V. Proposed Procedural Schedule

Staff proposes the following procedural schedule:

**Subject: Docket 46451,** Application of the City of Royse City to Amend its water and sewer Certificates of Conveniènce and Necessity and Decertify a portion of Verandah Municipal Utility District's Service Area in Hunt and Rockwall Counties

On October 18, 2016, the City of Royse City (City) filed with the Public Utility Commission of Texas (Commission) an application to amend its water and sewer Certificate of Convenience and Necessity (CCN) Nos. 12827 and 20813 and to decertify a portion of Verandah Municipal Utility District's (Verandah MUD) water and sewer CCNs in Hunt and Rockwall Counties. The application is being reviewed for administrative completeness pursuant to Tex. Water Code Ann. §§ 13.242-13.250 (TWC) and 16 Tex. Admin. Code §§ 24.101-24.107 (TAC).

A Staff review of the application found that it is sufficient in the required application and mapping information. In addition, the application makes clear the City seeks to cancel Verandah MUD's water and sewer CCNs rather than decertifying a portion of Verandah MUD's water and sewer CCNs as indicated by the style of the docket. Staff accordingly attaches a corrected notice to indicate the cancellation of Verandah MUD's water and sewer CCNs. Staff recommends that the application be deemed sufficient for filing and found administratively complete.

Staff further recommends the following:

£

- 1) The Applicant be ordered to provide the attached corrected notice of the application to the following:
  - a) any districts, utilities, and cities within two (2) miles of the proposed area;
  - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
  - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified;
  - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN is located; and
  - e) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Hunt and Rockwall Counties.

2) The Applicant provide the attached correct notice of the application to the following entities:

- BHP WSC (CCN No. 10064)
- Cash SUD (CCN No. 10824)
- Hunt County Judge
- North Texas MWD
- Rockwall County Judge
- Sabine River Authority
- Verandah MUD (CCN Nos. 13101 and 20958)
- 3) The Applicant be ordered to include copy of a map showing the proposed service area with the individual notices to neighboring utilities, other affected parties and each landowner. It is the Applicant's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained from the Texas Commission on Environmental Quality's web site located at <u>http://www14.tceq.texas.gov/iwud/</u>.
- 4) The Applicant file within 30 days of the Commission order, a copy of the actual notice and map issued, along with signed affidavits indicating that the notice was given. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.

The City of Royse City has filed an application with the Public Utility Commission of Texas to amend its Certificate of Convenience and Necessity Nos. CCN No. 12827 and 20813 for the provision of water and sewer utility service in Hunt and Rockwell Counties.

The proposed utility service area is located approximately 2 mile(s) east of downtown Royse City, Texas, and is generally bounded on the north by Interstate Hwy 30; on the east by FM 2642; on the south by FM 35; and on the west by FM 2642.

A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.

If a public hearing is requested, the Commission will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the proposed area, you may request to be excluded from the proposed area (or "opt out") by providing written notice to the Commission within (30) days from the date that notice was provided by the applicant. All requests to opt out of the requested service area must include a large scale map and a metes and bounds description of the tract of land.
