TO THE HONORABLE ADMINISTRATIVE LAW JUDGE OF THE STATE OFFICE OF ADMINISTRATIVE HEARINGS:

COMES NOW, North Collin Special Utility District ("NCSUD"), by and through its counsel, and files this Agreed Motion for Extension of Deadline to File Procedural Schedule, and in support thereof would state as follows:

- 1. On February 16, 2017, a telephonic prehearing was held in this proceeding. After the prehearing, SOAH Order No. 4 ordered the parties to confer and file a proposed procedural schedule by March 24, 2017.
- 2. Altoga Water Supply Corporation ("<u>Altoga WSC</u>"), NCSUD, and City of Princeton are actively engaged in settlement negotiations regarding this case. North Collin SUD requests that the March 24, 2017 deadline be extended for a period of twenty-one (21) days, until April 14, 2017 to allow such settlement communications to continue.
- 3. If the parties have not reached a settlement by April 14, 2017, the parties will propose a procedural schedule by said date.
- 4. The undersigned has conferred with the attorneys for Altoga WSC, City of Princeton and Public Utility Commission, and each have indicated that they are not opposed to this motion.

#### **PRAYER**

WHEREFORE, the undersigned requests the Honorable Administrative Law Judge grant this Motion and extend the deadline for filing a procedural schedule to April 14, 2017.
