STATUS REPORT REGARDING PROCEDURAL SCHEDULE

To the Administrative Law Judge Holly Vandrovec:

COMES NOW the City of Princeton, Texas ("City" or "Princeton") by and through its Counsel of Record, Arturo D. Rodriguez, Jr., and files this Status Report Regarding Procedural Schedule. In support thereof, the City would respectfully state as follows:

- 1. SOAH Order No. 8 granted an extension of the deadline for the parties to submit a procedural schedule in this Docket until August 18, 2017 in order to allow settlement between Parties to continue.
- 2. At the time of the request for extension, the City, North Collin SUD ("N. Collin") and Altoga Water Supply Corporation ("Altoga") had come to an agreement in principal. N. Collin and Altoga have since approved the agreement.
- 3. Princeton's City Council will consider the agreement at is regularly scheduled meeting on August 21, 2017. The parties have, thus, not prepared a procedural schedule in anticipation of settlement.
- 4. In the event the City of Princeton does not approve the settlement agreement on August 21, 2017, the City will work with N. Collin and Altoga to provide a procedural schedule by August 25, 2017. If the City does approve the agreement on August 21, 2017, the City or another Party will notify the Court of said settlement.
