COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Retitled Map in response to Order No. 8 and would show the following:

I. BACKGROUND

On October 25, 2016, the Estate of MJ Wootan and Deer Country Water Supply Corporation (Deer Country WSC) filed their application with the Commission. The Estate of MJ Wootan and Deer Country WSC request that the Commission approve the sale and transfer of a water system and a corresponding water certificate of convenience and necessity (CCN No. 12465) for a certificated service area in Llano County, Texas. The Estate of MJ Wootan is the seller, and Deer Country WSC is the purchaser. On June 29, 2017, the parties filed a Joint Motion to Admit Evidence that included a consented map depicting the requested CCN transfer.

On July 14, 2017, Order No. 8 was issued, directing Staff to provide a retitled map on or before July 19, 2017. This pleading is therefore timely filed.

II. RETITLED MAP

As directed by Order No. 8, a retitled map is attached to this pleading. The revised title indicates that the service area is being transferred from the Estate of MJ Wootan to Deer Country WSC. Prior to filing, Staff provided the retitled map to the parties for review. No party objected to the retitled map.

III. CONCLUSION


Staff provides the attached retitled map as directed by Order No. 8.



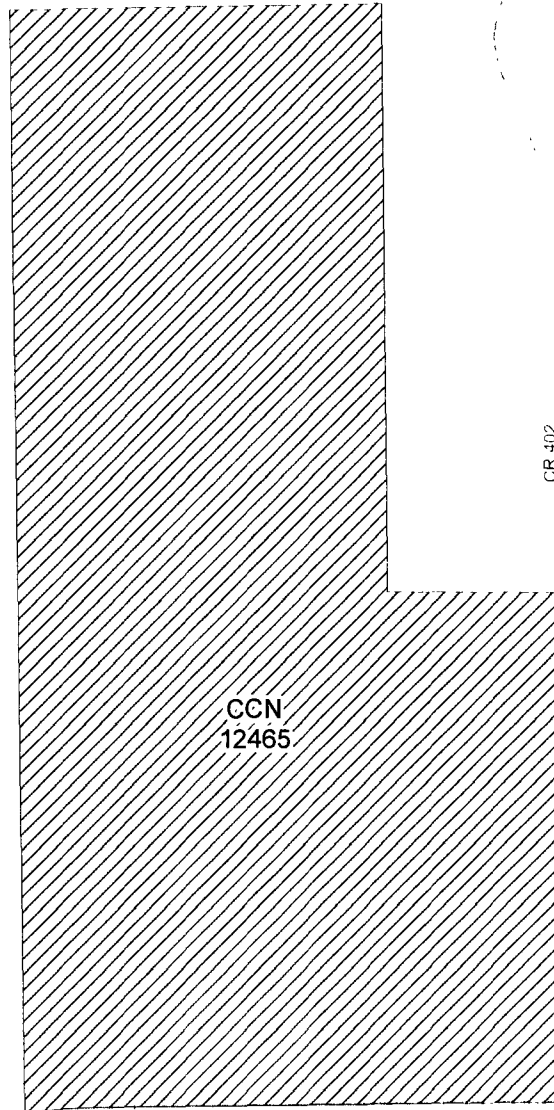
