

RE: RATE CHANGE FOR SEWER SERVICES

Dear Tenant:

Please note that the standard rate for sewer charges being charged to you by Riverside Waste Water Treatment Plant (RWWTP) has been well below market and city rates for years. We have maintained our rates of \$20.20, while city rates have increased to over \$55.00 per customer in some cases.

In 2013, we installed a new plant and facility to service the area at our own cost due to the system needing many upgrades and renovations. In order to cover the costs of operating the new facility and maintaining it to the standards required to serve the area, we have applied for a sewer rate increase with the State of Texas. This application is still under consideration, but we have been given a preliminary approval to increase our fees up to \$78.04 per customer (instead of \$20.20). **We understand that an increase like this is very tough on a user so we are not going to ask for that much from you. Although an increase of our rate to \$78.04 is within the state's limits for full recovery of our cost of operations, we are only increasing our rates to \$38.00 per existing customer user. This smaller increase is still well below the market city rates in the area.**

New move-ins to the serviced area, however, will be charged \$52.00 (still well below what our increased rate is for, pending state approval). **Existing users, such as yourself, will only be charged \$38.00.** These new charges will take effect on July 1, 2017.

To Summarize your new monthly charges for sewer services starting July 1, 2017:

Existing Users of Riverside Waste Water Treatment Plant (You): **\$38.00**
New Users (People moving in to the area serviced by the plant that don't already live here): **\$52.00**

Your account will be charged \$38.00 per month for sewer starting on July 1, 2017. Please make all payments to RWWTP at the above noted office address starting on that date.

ORDER NO. 4**FINDING APPLICATION REMAINS DEFICIENT AND INCOMPLETE;
ESTABLISHING DEADLINES**

This Order addresses the sufficiency of Riverside Waste Water Treatment Plant's application. Commission Staff recommended that the application is deficient as specified in the memorandum of Andrew Novak and Patricia Garcia of the Commission's Water Utility Regulation Division. Under 16 Texas Administrative Code § 24.8(d), an application is not considered filed until the Commission makes a determination of administrative completeness; thus, at this time, the application is not considered filed with the Commission.

The application is deemed deficient and incomplete. On or before May 19, 2017, applicant shall amend the application to cure the deficiencies noted by Commission Staff. On or before June 2, 2017, Commission Staff shall file a supplemental recommendation regarding the administrative completeness of the application and notice along with a proposed procedural schedule, if appropriate.
