**SOAH ORDER NO. 2  
CONTINUING PREHEARING CONFERENCE**

On December 21, 2017, the parties filed a Joint Request to Revise Prehearing Conference Date. The prehearing conference was scheduled for January 4, 2018. The parties request additional time so that effective notice of the prehearing conference can be provided.

The request is granted. The parties shall confer and agree on a date and time for the prehearing conference in consultation with the docketing department of the State Office of Administrative Hearings (SOAH), which can be reached at 512-475-4993. Once a date is selected, Riverside Wastewater Treatment Plant shall provide at least 20 days' notice of the prehearing conference to its customers, which notice shall include the date and time of the prehearing conference and state:

A prehearing conference will be convened on [date and time] at the State Office of Administrative Hearings, 300 West 15th Street, 4th Floor, Austin, Texas. Matters that may be discussed include procedures, pending motions, possible settlement of issues, the procedural schedule (including the hearing date), and other matters that may aid in efficient and fair processing of this case. Persons who attend the prehearing conference must first check in with building security personnel in the building's lobby to be issued visitor badges, and therefore should allow sufficient time for the check-in procedure.

Any person who wants to intervene in this case (i.e., participate in this case as a party) shall move to intervene either (1) in a written motion to intervene filed at the Commission no later than 3:00 p.m., the day before the prehearing conference; or (2) orally at the prehearing conference. Any filed motion shall refer to SOAH Docket No. 473-18-1394.WS and PUC Docket No. 46556, include enough information for the party to be contacted, and otherwise comply with the Commission's procedural rules. Previous submission of a protest does not meet the requirement that a person who wants to participate as a party must move to intervene as described above.

Once a date is confirmed with SOAH's docketing department, the parties shall immediately inform the ALJ of the date and time of the prehearing conference.
