CITY OF LIBERTY HILL'S AMENDMENT TO CCN APPLICATION

Administrative Law Judge Farhadi:

The City of Liberty Hill ("Liberty Hill") filed its application to amend its certificate of convenience and necessity on November 28, 2016. The City of Leander ("Leander"), as an affected party, requested a public hearing on April 13, 2017 stating that portions of the application are located with Leander's city limits and ETJ.

Since that filing, both cities have worked to resolve Leander's concerns. Accordingly, Liberty Hill has redrawn its map to exclude Leander's affected portions from its proposed service area. A complete description of the changes is included here. (See Letter of Chris Robertson, Engineer, City of Liberty Hill, attached.)

Liberty Hill hereby amends its Application to reduce the original geographic area requested, as more specifically depicted by the maps and digital data attached hereto as "Attachment A".

Dear Mr. Harris:

In response to "Docket No.46606 – Request for Hearing, City of Leander, TX", the City of Liberty Hills has removed all overlapping areas between the City of Liberty Hill's Proposed Sewer Service Areas within the City of Leander's extraterritorial jurisdiction (ETJ) and city limit boundaries.

An updated digital data copy of Leander's ETJ and city limit boundary was obtained on April 25, 2017 from the City of Leander and used to remove any overlap between the City of Liberty Hills Proposed Sewer Service Area and Leander's current city limits and ETJ boundaries. No new areas have been added to the City of Liberty Hill's Proposed Sewer CCN Service Area, and only areas with overlap between the City of Liberty Hill's Proposed Sewer CCN Service Area and either, or both, the City of Leander city limits and ETJ have been removed.

Attached you will find updated maps and GIS data reflecting the revised City of Liberty Hills's Proposed Sewer Service Area.
