JOINT STATUS REPORT

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE FARHADI:

COMES NOW, the City of Liberty Hill ("Liberty Hill"), the City of Leander ("Leander"), and the Staff of the Public Utility Commission of Texas ("Staff"), collectively, "the Parties", and file this their Joint Status Report in the above-referenced proceeding pursuant to this Court's Order No. 2 of May 31, 2017, and would show as follows:

On November 28, 2016, Liberty Hill filed its application to amend its certificate of convenience and necessity (CCN) No. 20969 in Williamson County to increase its service area to 5,671 acres and 622 current customers by including an additional 695,9701 acres to its certificated area ("Application"). On April 13, 2017, Leander, as an affected party, requested a public hearing stating that portions of the Application are located with Leander's city limits and extraterritorial jurisdiction. Subsequently, after discussion between Liberty Hill and Leander, Liberty Hill filed an amended application on May 19, 2017 in which Liberty Hill redrew its map to exclude Leander's affected portions from Liberty Hill's proposed expanded service area.

A prehearing conference was held on May 30, 2017 at which the Parties requested additional time for resolution via settlement. This Court granted the request ordering either a status report, a motion to remand or an agreed procedural schedule to be filed by July 11, 2017. The Parties hereby submit this their status report in compliance.



Liberty Hill and Leander met on July 7, 2017 and resolved all outstanding issues. Based on Liberty Hill's amendment of its application, Leander has filed its motion to withdraw. Following this, the Liberty Hill and Commission Staff will confer on the drafting and submission of their joint motion to remand to include settlement documents, including supporting evidence and proposed findings of fact and conclusions of law, as requested by this Court. A status report updating the process on the motion to remand will be filed by August 9, 2017.

The undersigned has consulted with the Parties who concur with this Status Report and agree to its filing.
