**COMMISSION STAFF'S REQUEST TO AMEND PROCEDURAL SCHEDULE**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this request to amend the procedural schedule. In support thereof, Staff shows the following:

**I. BACKGROUND**

On December 6, 2016, Aqua Texas, Inc. d/b/a Aqua Texas (Aqua) filed with the Commission an application to amend its water certificate of convenience and necessity (CCN) No. 13201 in Hood and Somervell Counties. Order No. 3, issued on February 16, 2017, set the deadline for Staff to provide final documents to Aqua for consent as April 13, 2017.

**II. PROCEDURAL SCHEDULE**

Due to Staff filing discovery requests in this docket, Staff requires additional time to finish preparing the final documentation. Staff received Aqua's response to Staff's RFIs on April 5, 2017 and therefore Staff requests an amended procedural schedule in order to allow time for Staff to finish final mapping.

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent if no outstanding issues exist	May 5, 2017
Deadline for Applicant to file signed consent forms with the Commission	May 19, 2017
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	June 6, 2017
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	June 13, 2017

### III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above recommendation.




