ORDER NO. 3 FINDING NOTICE SUFFICIENT AND ESTABLISHING DEADLINES FOR REMAINDER OF PROCEEDING

This Order addresses Commission Staff's recommendation on notice and proposed procedural schedule. Commission Staff stated that on January 25, 2017, applicants filed affidavits of proof of notice to current customers, neighboring systems, and cities. Notice was completed on January 13, 2017, therefore, the 120-day deadline to approve the sale administratively or require a public hearing is May 15, 2017. Commission Staff proposed a procedural schedule based on that deadline.

Consistent with Commission Staff's recommendation, the notice is sufficient. The following procedural schedule shall apply:

¹ Because 30 days after January 13, 2017, is February 12, 2017, a Sunday, the intervention period shall conclude on February 13, 2017, in accordance with 16 Texas Administrative Code § 22.4(a) (TAC).

² Under 16 TAC § 24.109, the deadline for Commission action is 120 days after the later of either the date the application is filed, notice is mailed, or notice is published. Because 120 days after January 13, 2017, is May 13, 2017, a Saturday, the deadline for Commission action concludes May 15, 2017, in accordance with 16 TAC § 22.4(a).
