APPLICANTS' SUPPLEMENT TO THE COMMISSION STAFF'S RECOMMENDATION

COMES NOW Lannius Municipal Utility District a/k/a Lannius Water Supply Corporation ("Lannius") and Bois D'Arc Municipal Utility District ("Bois D'Arc") (collectively, the "Applicants" or the "Districts") and files this Supplement to the "Background" section of the Commission Staff's Recommendation filed on March 15, 2017.

BACKGROUND

On May 6, 2016, the Applicants entered into a Consolidation Agreement pursuant to Texas Water Code §§ 54.729 - .731. On May 7, 2016, an election was held by both Lannius and Bois D'Arc, wherein the registered voters residing within the political boundaries of the respective Districts approved the consolidation of the Districts. On May 10, 2016, pursuant to the orders canvassing the election in both Districts, the Districts consolidated with Bois D'Arc being the surviving District.

On December 7, 2016, the Applicants filed an application for the sale, transfer, or merger of facilities in Fannin County, Texas (the "Application"). The Application covers an area of approximately 420 acres and 112 current customers. The proposed service area is located approximately 1.3 miles east/northeast of Dodd City, Texas. The Application requests the transfer all of Lannius' water certificate of convenience and necessity ("CCN") No. 11163 to Bois D'Arc and the amendment of Bois D'Arc's water CCN No. 11753.
