CITY OF KYLE'S MOTION FOR EXTENSION OF TIME

COMES NOW the City of Kyle (the "City"), applicant in the above-styled Docket, and files this Motion for Extension of Time ("Motion"). In support thereof, the City would respectfully show as follows:

I. BACKGROUND

On March 12, 2018, the City received electronic correspondence from the Public Utility Commission ("Commission") Staff ("Staff"), containing drafts of maps depicting the certificate of convenience and necessity ("CCN") boundaries of the City, County Line Special Utility District ("County Line SUD"), and Monarch Utilities I ("Monarch"), as revised by the requests in the City's above-listed application ("Application"). Commission Staff then filed a Status Report on March 14, 2018, noting that final consent documents for the revised CCN had been emailed to the City, and that Staff was in the process of preparing its final recommendation on the Application. This Status Report also requested that the Administrative Law Judge set (i) the deadline for filing consent forms to March 26, 2018, (ii) the deadline for Staff's final recommendation to April 2, 2018, and (iii) the deadline for parties to file joint proposed findings of fact and conclusions of law to April 9, 2018 (collectively, the "Deadlines"). Order No. 11, adopting Staff's proposed deadlines was issued on March 20, 2018. Therefore, this pleading is timely filed.

II. MOTION FOR EXTENSION

The City respectfully requests the Commission grant a one-month extension on all of the Deadlines. On March 23, 2018, County Line SUD returned its executed Consent Form to the Commission, indicating that it does not concur with the map and certificate transmitted by email on March 9, 2018. While this response was not expected by the City, the City anticipates that the issue of concern is minor and can be resolved amicably by the parties. To this end, the City is coordinating with County Line SUD to understand its concern and leading the effort to develop a revised CCN map that all parties can agree to.

It is important that all parties support and consent to the final map and certificates, and the City believes that a one-month extension will afford the parties enough time to reach a final agreement on the maps, in coordination with Commission Staff. The City has conferred with Staff regarding this Motion, and it is the City's understanding that counsel for Commission Staff supports this Motion.

III. PRAYER

The City of Kyle respectfully requests that the Public Utility Commission grant this Motion for Extension of Time, and for all other relief to which it is entitled.


