### **NOTICE FINDING APPLICATION SUFFICIENT, REQUIRING RE-NOTICING, CHANGING EFFECTIVE DATE AND ESTABLISHING DEADLINES**

This Notice addresses Commission Staff's January 10, 2017 recommendations in this application, as detailed in the pleading and in the attached memorandum of Ricky Herrera of the Commission's Water Utility Regulation Division. Commission Staff recommended that this application be deemed administratively complete; however, Staff stated that Orbit Systems, Inc.'s notice of this application contained an error. Commission Staff stated that Orbit's original notice of this application included language contained in an old version of 16 Texas Administrative Code § 24.21(TAC). The rule was revised before Orbit filed this application, therefore Orbit's notice should have included the new rule language. For this reason, Commission Staff recommended that Orbit be required to provide revised notice using the correct language and therefore, that the effective date be changed to February 1, 2017. Commission Staff requested a January 20, 2017 deadline to provide a final recommendation and a revised tariff.

Consistent with Commission Staff's recommendation, this application is deemed administratively complete; however, Orbit shall provide revised notice of this application consistent with Commission Staff's January 10, 2017 pleading and attached memorandum. No later than January 19, 2017, Orbit shall submit a copy of the actual notice provided. The proposed effective date for this application is changed to February 1, 2017. On or before January 20, 2017, Commission Staff shall provide a recommendation on final disposition and a revised tariff.
