**REQUIRING RE-NOTICING
AND ESTABLISHING DEADLINES**


This Notice addresses Commission Staff's January 20, 2017, recommendations in this proceeding. On January 17, 2016, a notice was issued in this proceeding that deemed Orbit Systems, Inc.'s application administratively complete, but due to incorrect language in the original notice provided, required the company to re-notice the application with corrected notice. That notice also changed the proposed effective date of the application to February 1, 2017 and required Orbit to file proof of re-noticing by January 19, 2017. Orbit has made no filings in this proceeding since the January 17, 2017 notice was issued.

On January 20, 2017, Commission Staff stated that in order to make a recommendation on final disposition in this application, Orbit must provide notice of this application prior to the effective date and file proof of notice. Therefore, Commission Staff recommended that Orbit provide notice by January 27, 2017, prior to the proposed effective date of February 1, 2017, and file proof of notice no later than February 3, 2017. Commission Staff proposed to file a recommendation on final disposition within five working days of Orbit filing proof of notice.

Orbit must re-notice this application before the beginning of the period in which the revision takes place,¹ otherwise Commission Staff cannot complete its review of the application and provide a recommendation on final disposition; for approval or denial. Therefore, consistent with Commission Staff's recommendation, Orbit shall re-notice this application with corrected notice no later than January 27, 2017 and file its proof of notice by February 3, 2017. If Orbit fails to re-notice this application by January 27, 2017 or does not properly correct the notice that is provided, the proposed rate cannot go into effect on February 1, 2017. Within five working days of Orbit filing its proof of notice, but no later than February 10, 2017, Commission Staff will file a further recommendation in this application.
