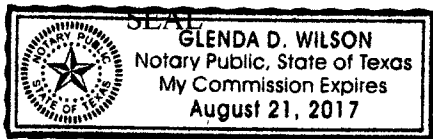

EFFECTIVE DATE OF CHANGE: February 1, 2017 as approved by the Public Utility Commission

1" METER MONTHLY BASE RATE: \$70.00 (includes 0 gallons)

TCEQ REGULATORY ASSESSMENT FEE: 1% of retail monthly bill
WATER USE FEE: \$2.75 per 1000 gallons

NEW CALCULATION OF CUSTOMER BILLING:

1" METER MONTHLY BASE RATE: \$70.00 (includes 0 gallons)
