 We, the undersigned ratepayers of Suburban Utility Co. Inc. hereby appeal the decision of the board of directors of Suburban Utility Co. Inc. affecting the rates charged to them by Suburban Utility Co. Inc. The rate change and surcharge was effective on February 3, 2017 and affected the rates charged for water utility service, transfer fee, late charges, reconnect fees, and returned check fee. Additionally Proposed is a \$20.00 monthly surcharge per connection for 60 months.
 On or around 12/29/2016 the ratepayers were notified by the service provider of this rate increase. The undersigned request that the Public Utility Commission of Texas (PUC) review the decision to determine if the rates established are just and reasonable.
 The old rates charged by the service provider are: Existing 5,000 gallons = \$33.75 month/ Proposed 5,000 gallons = \$62.30 month. The undersigned designate Ms. Gloria H. Joy as the representative for the Beaumont Place subdivision 281/458-9762 and Ms. Pat Hill as the representative for the Reservoir Acres subdivision, 281/732-2227.
