OFFICE OF PUBLIC UTILITY COUNSEL'S RESPONSE TO SUBURBAN'S OBJECTION TO REPRESENTATION OF CUSTOMERS

The Office of Public Utility Counsel (OPUC) files this response to Suburban Utility Company, Inc.'s (Suburban) Objection to Representation of Customers by the OPUC Without Written Authorization and/or Requiring the Identification of Parties. OPUC requests the ALJ deny Suburban's objection and in support thereof shows the following:

I. Argument

The Office of Public Utility Counsel's (OPUC) authority to intervene in proceedings is governed by Texas Water Code Section 13.017. Under TWC § 13.017, OPUC may appear or intervene, as a party or otherwise, as a matter of right on behalf of residential consumers, as a class, in any proceeding before the utility commission. TWC § 13.017(b)(3)(A). Further, under TWC § 13.017(b)(3)(B) OPUC may appear or intervene, as a matter of right on behalf of small commercial consumers, as a class, in any proceeding in which the counsellor determines that small commercial consumers are in need of representation. The statue does not require OPUC to provide written proof of its authority to represent residential and small commercial consumers as that authority is granted by statue and no other evidence is required.

Suburban relies on 16 TAC § 22.101(a) and 1 TAC § 155.201(a) to claim that OPUC must identify and provide written proof of the individual consumers OPUC represents. Neither provision supports this claim. These provisions are set out in full below:

16 TAC § 22.101(a) Any person may appear before the commission or in a hearing in person or by authorized representative. The presiding officer may require a representative to submit proof of his or her authority to appear on behalf of another person. The authorized representative of a party shall specify the particular persons or classes of persons the representative is representing in the proceeding.¹

1 TAC § 155.201(a) A party may represent himself or herself or may appear by authorized representative. Parties that are not represented by an attorney may obtain information regarding contested case hearings on SOAH's public website at www.soah.texas.gov.²

Commission rule 16 TAC § 22:101(a) is satisfied upon the authorized representative specifying the particular persons or classes of persons that the representative is representing in the proceeding. SOAH rule 1 TAC § 155.201(a) is inapplicable. To the extent proof of representation of a class of persons is required, please see OPUC's motion to intervene in this docket,³ and Texas Water Code, § 13.017. Nothing requires OPUC to identify particular individual residential or small business customers. Accordingly, Suburban's objection is without merit and should be denied.

II. Conclusion

For the reasons discussed herein, OPUC requests that the ALJ deny Suburban's objection, and grant OPUC such further relief to which it may be entitled:
