TEMPORARY MANAGER'S STATUS REPORT

Quadvest LP, in its capacity as Temporary Manager of Suburban Utility Company, Inc., ("Temporary Manager") files this Status Report in the above-captioned proceeding. In support thereof, Temporary Manager respectfully shows as follows:

On March 27, 2017, the Executive Director of the Texas Commission on Environmental Quality ("TCEQ") issued an Emergency Order pursuant to TEX. WATER CODE chs. 5 and 13, TEX. HEALTH & SAFETY CODE ch. 341, and 30 TEX. ADMIN. CODE chs. 35, 290, and 291, appointing Quadvest L.P. as Temporary Manager of the public water systems at issue in this docket.¹ This Emergency Order was affirmed at the Open Meeting before the Commissioners of the TCEQ on May 24, 2017.² Furthermore, it was announced that Suburban Utility Company, Inc. was in discussions with a third party to purchase its system. Therefore, Temporary Manager believes that this matter should continue abated at this time.

FOR THESE REASONS, Temporary Manager requests that the Commission continue to abate this proceeding, and grant all other relief, to which it is justly entitled.
