QUADVEST L.P.'S MOTION TO WITHDRAW INTERVENTION

Quadvest L.P., former Temporary Manager of Suburban Utility, Inc., files this Motion to Withdraw Intervention in the above-captioned proceeding and in support thereof respectfully shows as follows:

1. On March 27, 2017, the Executive Director of the Texas Commission on Environmental Quality issued an Emergency Order pursuant to Tex. Water Code chs. 5 and 13, Tex. Health & Safety Code ch. 341, and 30 Tex. Admin. Code chs. 35, 290, and 291, appointing Quadvest L.P. as temporary manager of the public water systems at issue in this docket.¹

2. On April 4, 2017, Quadvest L.P. filed a motion to intervene in this docket in its capacity as temporary manager. The Administrative Law Judge granted this motion on April 20, 2017.

3. Quadvest L.P.'s term as temporary manager expired on September 23, 2017. The Commission has appointed Undine Texas, LLC to replace Quadvest L.P. as temporary manager of Suburban Utility Company, Inc.² Therefore, Quadvest L.P. no longer has an interest in this proceeding and requests that the Commission grant its request to withdraw its intervention in this matter.

4. FOR THESE REASONS, Quadvest L.P. requests that the Commission grant its motion to withdraw, and grant all other relief, to which it is justly entitled.
