UNDINE TEXAS, LLC'S STATUS REPORT

COMES NOW, Undine Texas, LLC (Undine) and files this Status Report pursuant to SOAH Order No. 8.¹ SOAH Order No. 8 requires Undine to submit a written status report regarding the sale of Suburban Utility Company, Inc.'s (Suburban) facilities and certificate rights to Undine.

Acting as Temporary Manager of the utility, Undine requests that this proceeding continue to be abated until after the STM transaction closes and Undine becomes the owner of the Suburban systems, as described in Undine's previous Status Report, filed herein on February 2, 2018. Undine has filed for, and received, an extension of its status as Temporary Manager until May 5, and the Commission will hold a public hearing on April 12 to confirm that extension.² In addition, Undine has filed for an extension of the time allowed for closing the transaction for good cause shown, requesting an extension that coincides with the extension of the temporary management.³

As set forth in those filings, significant effort and resources are being expended in order to resolve issues that will allow closure of the sale transaction to take place, and that will allow




