Staff Question 1-1:

Please provide evidence indicating whether the improvements contemplated in Exhibit G of the development agreement will constitute an estimated change of more or less than 10% of the number of connections in the existing system.

Response No. 1-1:


The improvements contemplated in Exhibit G are intended to service approximately 510 new connections to the City of Haslet water system. The City of Haslet currently has 792 active connections in the existing water system. Therefore, the improvements will constitute an estimated change of more than 10% of the number of existing connections in the system.





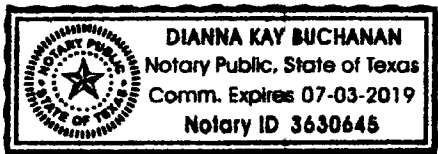
