ORDER NO. 3 DEEMING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's April 4, 2017 recommendation that the notice of this application provided by the City of Haslet was sufficient and Commission Staff's proposed procedural schedule for continued processing. Commission Staff stated that Haslet submitted an affidavit indicating notice was published in the Fort Worth Star Telegram, which is generally circulated in Tarrant, Wise, Hood, and Johnson counties, on February 25, 2017 and March 4, 2017. Additionally, Commission Staff stated that Haslet mailed notice to the landowners on March 1, 2017.

Consistent with Commission Staff's recommendation, the notice provided by the City of Haslet is sufficient. Additionally, Commission Staff's procedural schedule is adopted as proposed:
